Based on the facts of this case, the Office of the Deputy Attorney General concurs with your office that the investigation, prosecution, and conviction of Mr. Lynch are entirely consistent with Department policies as well as public statements made by the Attorney General. Accordingly, you should seek to proceed with the sentencing recommendations which your office has filed with the court.

Dear Ms. Jones:

This responds to your letter dated May 11, 2009, to the Attorney General of the United States, Eric H. Holder, Jr., regarding the conviction of your son, Charles C. Lynch, in the Central District of California, Case CR No. 07-689-GW.

As I noted in my April 17, 2009, letter to United States Attorney Thomas O'Brien, which was presented to the district court, "[b]ased on the facts of this case, the Office of the Deputy Attorney General concurs with [the United States Attorney's Office for the Central District of California] that the investigation, prosecution, and conviction of Mr. Lynch are entirely consistent with Department policies as well as public statements made by the Attorney General." Additionally, as you know, Mr. Lynch's case was fully litigated in federal court. After a unanimous jury verdict of conviction on all counts, he is awaiting sentencing.

Because Mr. Lynch is represented by legal counsel, and this is a pending matter, ethical rules preclude us from communicating with him except through his attorney. His counsel should contact the Assistant United States Attorney handling this matter to address any additional issues.
