Lynch's motion to file exhibit J to his "Notice and Request for a McIntosh Remand or Relief" ("Notice") and the motion to seal itself under seal (Docket Entry No. [138]) is granted. The Clerk shall file exhibit J to Lynch's Notice and the motion to seal under seal. Lynch's request to file an oversized brief in support of his Notice (Docket Entry No. [139]) is granted. The oversized brief was filed on March 3, 2017. The government's motion to file an oversized response to Lynch's Notice (Docket Entry No. [143]) is granted. The government's response was filed on March 23, 2017. Lynch's motions to file a late reply to the government's response (Docket Entry Nos. [145] & [146]) and to file an oversized reply (Docket Entry No. [148]) are granted. The oversized reply to the government's response was filed on April 24, 2017. Lynch's Notice (Docket Entry No. [137]) is denied without prejudice to renewing the arguments in the third cross-appeal brief. No motions for reconsideration of this denial will be entertained. Lynch's third brief on cross-appeal is due within 30 days of the date of this order. The government's fourth brief on cross-appeal is due within 21 days of the date of service of Lynch's third brief on cross-appeal. No further requests for extensions of time will be entertained.
