

1 GOOD CAUSE HAVING BEEN SHOWN, IT IS HEREBY ORDERED that the  
2 pretrial release conditions for Mr. Charles Lynch be modified to remove the condition  
3 ordered in Paragraph 1 of ECF No. 402 that:

4 Mr. Lynch is required to report in person to Pretrial Services  
5 once every three months, rather than once per month. He is  
6 required to contact the office of Pretrial Services by telephone  
7 once per week.

8 In place of this condition, the Court orders that the Pretrial Services Agency shall have  
9 discretion regarding Mr. Lynch's supervision. All other conditions of release are to  
10 remain in force.
